3. NOTES ON ACCOUNTS:

3.1 About Namma Roopanagara Residents Welfare Association (R) (The Association in short)- The Association is registered under the Karnataka Societies' Registration Act, 1960 vide No. DRMY/SOR/198/2021-22 dated 09-09-2021

The main objective of the Association is bringing together the residents of Roopanagar and undertakes activities for the welfare of its members and for the overall development of Roopanagar. Any person who has completed the age of 18 and who comes under the jurisdiction of the Association is eligible to become a member.

3.2 Classes of Members:

- i. Life Members fee Rs.15,000/- or more. As on 31-3-2023 total Life members were 26.

- 3.3 The Balance amount of Rs.12,100 receivable from Ashwin Kumar Kanchagar, a Life member towards his Life membership fees of previous year has been written off during the Current year and remaining balance Rs.2,900 has been adjusted towards annual membership fees and Rs.100 from Application fees.
